### Commitment to achieving Net Zero

ANITA UK Ltd is committed to achieving Net Zero emissions by 2050.

<ul style="list-style-type: none"><li>ANITA UK Ltd are an SME and this is the first time reporting emissions.</li><li>Due to limited time and peoplepower in our tiny team, we can report Scope 1 and Scope 2 emissions for a specified 12 month period at this stage and are required to submit this due to an upcoming government tender, despite Scope 3 being incomplete.</li><li>Scope 3 emissions are being tracked and calculated and will be available by October 2024 when we will have compiled a year's worth of data.</li></ul>

### Emissions Reduction Targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets:

- 25% reduction of postal transportation requirements (due to digitisation of invoices / statements) by mid-2024
- 50% reduction in electricity for office lighting by switching Halogens to LEDs by end 2024
- 25% reduction in paper by 2025
- 25% reduction in plastic consumption by 2025
- Electrification of company car fleet by 2027

We project that carbon emissions will decrease over the next five years to 23 tCO<sub>2</sub>e by 2027. This is a reduction of 17%. This does not account for the Scope 3 emissions which are yet to be calculated.

### **Carbon Reduction Projects**

#### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented before the 2023 baseline. As we have no specific data before 2023, we cannot calculate the reduction in tCO<sub>2</sub>e.

- The products that we sell on behalf of our parent company Anita GmbH have OEKO-TEX 100 certification.
- The OEKO-TEX STEP standard, which includes environmental - management and performance, was introduced in the first Anita production plant in 2023.
- The production plants for Anita breast forms fulfil the Energy Service Act according to DIN 16247-1 (Energy Audit)
- All four of our UK company lease cars are now hybrid vehicles, the last of which was exchanged to hybrid from diesel in October 23.
- Duplex, black-and-white printing is the standard setting for all office printers.
- All our swimwear has been packed in re-sealable compostable cornstarch bags instead since 2022 avoiding the need for single-use poly bags. All our packaging is recyclable or biodegradable.
- We have a global companywide policy that no consumer giveaways are to be made of plastic, and indeed many are being made from leftover swimwear fabrics - eg hair-scrunchies, gym bags .
- We have a bra bank and a breast form bank at the UK office site to collect and donate old stock and customer returns /donations of bras and breast forms to a charitable organisation.

In the future we are implementing further measures including:

- When the company car leases are up for renewal in 2025, 2026 and 2027 respectively, we will look to electrification of the company fleet.
- Paper consumption is to be reduced through a project which is digitising statements and invoices in 2023, and by condensing information on delivery notes to avoid multiple pages.
- Digitisation of statements / invoices will also reduce postal transportation requirements.
- Switching to LED lighting in our UK office.
- Use of online mediums instead of paper for brochures and communications wherever possible.
- We are looking to establish a UK warehouse for easier local despatch, and which will allow deliveries from our parent company to the UK warehouse to be consolidated.

- Our parent company who manufactures ANITA products, already cover 25% of their energy needs with self-generated, green electricity, and have switched to 100% green electricity in the German and Austrian sites. They also intend to switch to 100% LED lighting in all their production facilities by 2025 which impacts the products that Anita UK sell on their behalf.
- Our parent company are planning to establish the ISO 14001 environmental management standard in order to better monitor our performance and achieve continuous improvement.
- Our parent company are working on certify all the remaining production plants according to OEKO-TEX STEP

### **Declaration and Sign Off**

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans. Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard 1. and uses the appropriate Government emission conversion factors for greenhouse gas company reporting 2. Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard 3.
